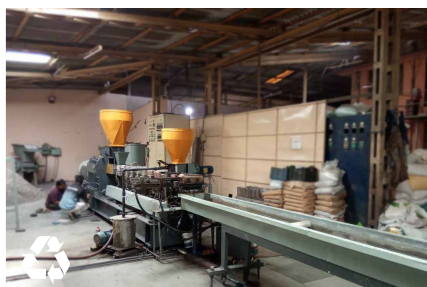


ABOUT US

Extended producer responsibility, refers to the responsibility for management of the disposal of products by producers once those products are designated as no longer useful by consumers. Our main objective is to develop an effective and efficient system that takes care of collection, segregation and transportation of the material to the waste disposal facility which is approved by the MPCB and SPCB. These materials are also used in cement kilns, pyrolysis, for road construction and recycling centers, on the basis of its quality and price.

HDPE INJECTION MOULDING (HDPE)

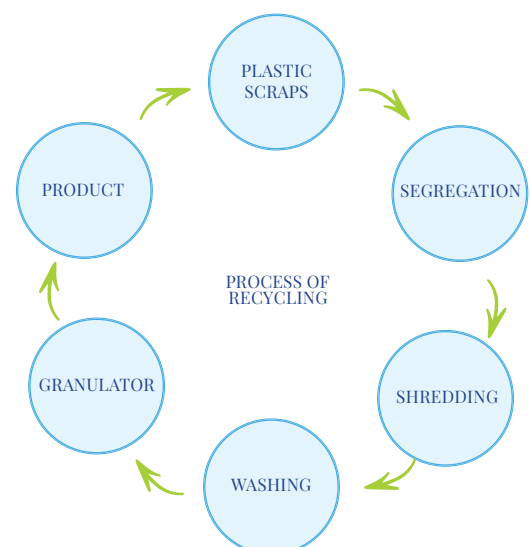

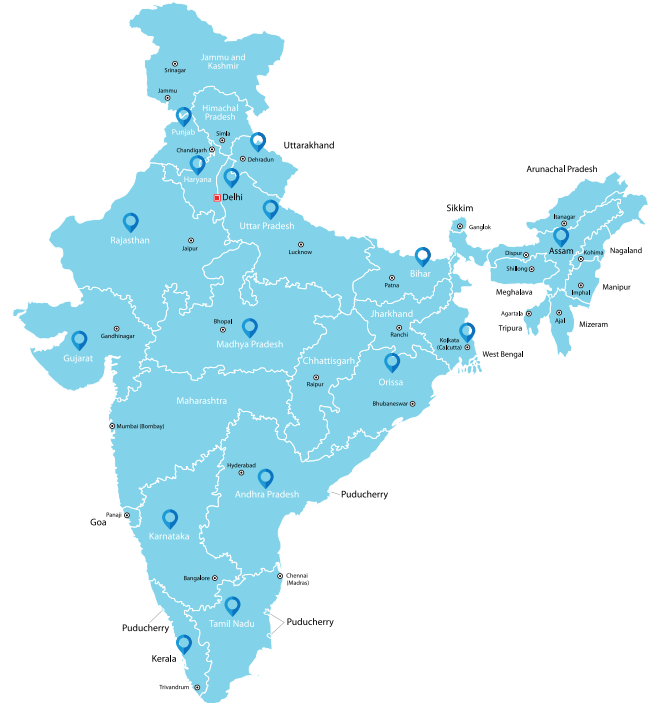

We collect both recyclable and non-recyclable plastic waste material, which are further processed at our 2 lac sq. ft. facility at Palghar and disposal of non-recyclable waste are being supplied to cement kilns, waste to energy plants, waste to roads, etc.

The Shakti Plastic Industries has taken step ahead encouraging Repro an NGO with vision to divert valuable waste from our landfills, water-bodies, drains and environment and back into the economy through a combination of education & awareness programs, implementation of segregation at source and create a waste free India in line with a circular economy, where no waste is left unsegregated or untreated and all waste is diverted from landfills, water bodies and environment.

THE PROBLEM

Urban India produces conservatively about 6.2 crore tonnes of Municipal Solid Waste every single day. Less than 70% of this is collected, less than 20% is treated, and more than 50% is dumped. Improper waste management leads to air, soil and water pollution and mixed waste is either sent to dumping grounds or burnt, causing pollution, health hazards and loss of valuable resource recovery and economic opportunities. The largest cause of our waste management crisis is a lack of segregation of waste at source into 3 basic waste streams- dry (recyclable), wet (organic and compostable) and reject (domestic hazardous waste).



AND WHAT DOES REPRO DO TO FIX PROBLEM?

Repro organizes programs and events (independently and in association with corporates) on a local basis in communities to assist and ensure diversion of waste from our drains, water bodies and landfills and back into the economy instead, primarily by diverting waste to recycling and co-processing units. This is done through education/awareness sessions, training for segregation of waste at source, and diversion of such segregated waste to composting (onsite or offsite), recycling or co-processing units. Repro helps corporates sector to implement and achieve their EPR targets.
